### Terms and Conditions of Entry

Promotor: Elements of Byron

Permit number: NTP/12275

Information on how to enter and prize details form part of these Terms and Conditions. Any entry not complying with these Terms and Conditions is invalid.

Entry is open to residents of Australia aged 18 years or older.

Employees of the Promoter, the Promoter's associated companies, the Promoter's agencies associated with this promotion, the participating outlets and their immediate families are ineligible to enter.

"Associated companies" includes without limitation, the agents and contractors of the Promoter that are involved in: (a) the promotion or development of the promotion; and (b) the manufacturer or distribution of the Promoter's products ("Eligible Entrants").
