

Elements of Byron – 10 Years. 10 Nights. Competition

Terms & Conditions

1. Promoter

The promoter is Elements of Byron, 144 Bayshore Drive, Byron Bay NSW 2481 ("Promoter").

2. Competition Period

The competition commences at 8.00am AEST on 25 June 2026 and closes at 4pm AEST on 31 August 2026 ("Competition Period").

3. Eligibility

Entry is open to Australian residents aged 18 years and over.

Employees of Elements of Byron, associated agencies, prize suppliers and their immediate family members are ineligible to enter.

4. How to Enter

To enter, entrants must:

- Complete the competition entry form during the Competition Period; and
- Answer the question in 25 words or less:

"In 25 words or less, tell us why you should win 10 nights of connection at Elements of Byron."

Only one (1) entry per person is permitted unless otherwise stated.

5. Game of Skill

Each valid entry will be individually judged based on originality, creativity and relevance to the competition question.
